




AION IS THE NAME OF THE MALTHOUSE BEQUEST PROGRAM

A bequest is the act of leaving something in your Will or giving something in your Will to an individual or organisation. Different organisations may use different terminology such as legacy giving and may recognise bequests as those that have been realised and those that have been notified.

Bequests can sometimes feel like a complicated process. In fact, bequests can be made by anyone using some simple wording in a Will. Below are some common ways that people include a bequest in their Will for a not-forprofit organisation like Malthouse:

- A percentage of the estate
- After family and friends have been recognised, the remainder of the estate could be left to a charitable organisation(s), often called the residual of the estate or the residue
- A specified cash amount


- A specified asset(s) including but not limited to stocks, property, or artwork collections
- As an alternative option if a bequest cannot be carried out. For example, an individual beneficiary has passed away and as an alternative the asset then passes to a nominated charitable organisation
- A bequest with conditions that must be met prior to the bequest being carried out. For example, an estate is retained by a spouse for the duration of their lifetime before it passes to the beneficiaries

THANK YOU FOR REMEMBERING US IN YOUR WILL

When you make a bequest in your Will we do highly recommend you seek advice from a solicitor of financial advisor. Below is some suggested wording as a guideline, but this may need to be adjusted depending on your individual circumstances.

TO RECOGNISE MALTHOUSE IN YOUR WILL:

free from all duties. My gift is for the use and benefit of Malthouse Theatre at its absolute discretion. I declare that the receipt in writing of an authorised officer of Playbox Theatre Company Limited t/as Malthouse Theatre for the time shall be a sufficient discharge to my executors.

If the organisation cannot receive the relevant gift, then the gift shall be made to the charitable organisation in Australia that my executors consider most nearly fulfills the objects I intend to benefit.

TO RECOGNISE A SPECIFIC MALTHOUSE PROGRAM IN YOUR BEQUEST:
